Caucus Meeting @ NACo

On February 22, members of the FAC Staff, Scott Shalley and Eric Poole, along with representatives of Gulf, Walton and Escambia Counties participated in a meeting among the offices of Senator Nelson, Representative Graham and U.S. Treasury. The discussion focused mainly on issues related to the development of individual Multi Year Implementation Plans and the implementation of Pot 1 monies under the RESTORE Act. However, on behalf of the Gulf Consortium Mr. Shalley and Poole were able to continue to discuss the issue of being able to use Pot 3 Comm. Robinson chairs Gulf Coast dollars for the issuance of debt. U.S. Treasury is interested in keeping the lines of communication open between Florida's counties and Treasury and between the

Gulf Consortium and Treasury.

Executive Committee meets

The Committee spent a fair amount of time in discussion on both the Planning Grant Application and the collaboration with the Restoration Council on achieving closure on the application's status. In addition, there was much discussion on the proposed revisions to the process of developing the State Expenditure Plan. Work is ongoing on both of those topics by the ESA Consultant Team and Consortium staff.

Gulf Consortium meets with Restoration Council

On Friday, February 12, Consortium staff, members of the ESA Consultant Team, Chair Robinson, and members of Florida's DEP met with Justin Ehrenwerth,

Executive Director of the Restoration Council and Mary Pleffner, CFO of the Restoration Council to discuss the status and updates to the Gulf Consortium's Planning Grant Application. The meeting was productive and collaborative. The result of the meeting is a substantial revision to the Consortium's grant application that will be presented, in draft and in person to the Council staff next week. Consortium staff, members of the ESA Consultant Team, and Mary Pleffner (Restoration Council CFO) will be meeting in person to review the Consortium's revised grant application in an effort to promote efficiency and collaboration in the approval process.

Welcome to Commissioner John Morroni, who is the new Pinellas County appointee to the Gulf Consortium Board of Directors. Continued discussion on the revised FSEP development process

Conversations between the ESA Consultant Team and the Gulf Consortium Executive Committee are on-going. At the Executive Committee meeting last Thursday, Doug Robison, Project Manager from ESA, facilitated a substantive discussion with the Committee on the most recent revisions [hyperlink to the agenda item here] to the process for developing Florida's State Expenditure Plan. The ESA Team, along with Consortium staff is continuing to reach out to RESTORE Act Coordinators and DEP staff to present, discuss, and receive feedback on these revisions to the development of Florida's plan. This work is being pursued with the goal of presenting final revisions to the full Board of Directors at its meeting on April 21 so that significant and substantive planning work can begin. Please continue to share feedback, concerns, questions and issues on these revisions with Consortium staff and/or the ESA Consultant Team.

Update on recent Consortium activities

While the Board will not meet again until April 21, much daily work is still ongoing on behalf of the Gulf Consortium. Here is a brief summary of all that is still happening:

- Continue weekly internal Consortium staff meetings
- Continue weekly ESA Consultant Team/Consultant staff meetings
- Attended and participated in a meeting among Consortium staff, ESA
 Consultant Team, and DEP staff (including Mimi Drew, Phil Coram, and Gareth
 Leonard) on Friday, January 29th to discuss the development of the FSEP.
- Attended and participated in a meeting among Chairman Robinson, Consortium staff, ESA Consultant Team members, Restoration Council staff and DEP staff on February 12, 2016 to discuss the Consortium's Planning Grant Application.
- Board communications plan has been developed and is being implemented by Consortium staff between now and the April 21 Board meeting.
- The first update newsletter was drafted and transmitted to all Board members on February 10, 2016.
- Continued Consortium staff guidance to the ESA Consultant Team on the development of the FSEP.
- Continued targeted county visits by Consortium staff.
- Coordinated conference call between Consortium staff and US Treasury staff on February 19.
- Participated in meeting among FAC staff (on behalf of the Consortium and counties), representatives from Gulf, Walton, and Escambia Counties, Senator Nelson, Rep. Graham and US Treasury in Washington, D.C. on February 22.
- Scheduled and publicized three Executive Committee meetings between February 1 and April 21.
- Participated in recent in person meetings with members of Florida's congressional delegation and US Treasury staff during February 20-24.
- Draft and transmit a letter, under Chairman Robinson's signature to US
 Treasury, outlining concerns over the question of whether RESTORE Act fines
 can be used to pledge against debt to finance the projects, programs and
 activities of the State Expenditure Plan.
- Schedule and prepare for a Consortium staff one-on-one briefing with the newly appointed Pinellas County Director of the Gulf Consortium Board, Commissioner John Morroni.
- Schedule and prepare for a RESTORE Act Coodinator's meeting in Pinellas County in March.
- Continued work with Warren Averett, the CPA firm conducting the FY 14-15 independent audit. The audit is on schedule for Board review in April.
